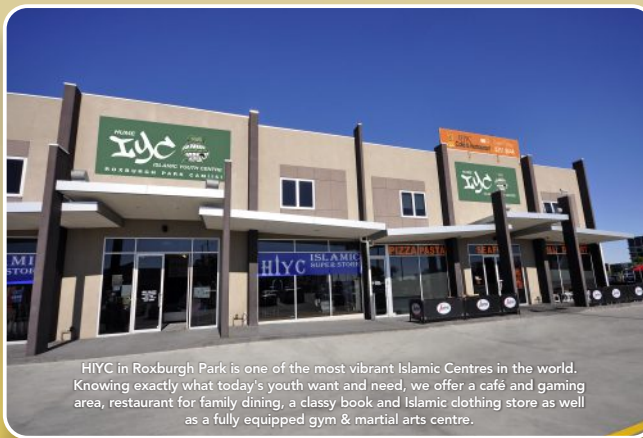

Direct Debit Request (DDR) Service Agreement

Direct Debit Request (DDR)

Please return your completed application by mail to PO BOX 2100 Meadow Heights, VIC. 3048

This is your Direct Debit Service Agreement with Hume Islamic Youth Centre (314011) 46 068 854 319. It explains what your obligations are when undertaking a Direct Debit arrangement with us. It also details what our obligations are to you as a Direct Debit provider. Please keep this agreement for future reference. It forms part of the terms and conditions of your Direct Debit Request (DDR) and should be read in conjunction with your DDR authorisation. All communication addressed to us should include your customer number.

DEBITING YOUR ACCOUNT

By signing a Direct Debit Request or by providing us with valid instruction, you have authorised us to arrange for funds to be debited from your account. You should refer to the Direct Debit Request and this agreement for the terms of the arrangement between us and you. We will only arrange for funds to be debited from your account as authorised in the DDR, OR we will only arrange for funds to be debited from your account if we have sent to the address nominated by you in the DDR, a billing advice which specifies the amount payable by you to us and the date it is due. If the debit day falls on a banking holiday, we may direct your financial institution to debit your account on the following banking day. If you are unsure about which day your account has or will be debited, you should ask your financial institution.

AMENDMENTS BY US

We may vary any details of this agreement or a DDR at any time by giving you at least 14 days written notice.

AMENDMENTS BY YOU

You may change, stop or defer a debit payment, or terminate this agreement by giving us with at least at least 7 days notification by writing to PO Box 2100, Meadow Heights, VIC. 3048 or calling us on (03) 8351 8003 during office hours or arranging it through your financial institution, which is required to act promptly on your instructions.

YOUR OBLIGATIONS

It is your responsibility to ensure that there is sufficient clear funds are available in your account to allow a debit payment to be made in accordance with the DDR. If there are insufficient clear funds in your account to meet a debit payment:

- > you may be charged a fee by your financial institution
 - > you may also incur fees or charges imposed or incurred by us, and
 - > you must arrange for the debit payment to be made by another method or arrange for sufficient clear funds to be in your account by an agreed time so that we can process the debit
- You must check your account statement to verify that the amount debited from your account are correct.

DISPUTE

If you believe that there has been an error in debiting your account, you should immediately notify us directly on (03) 8351 8003. Alternatively you can take it up directly with your financial institution. If we conclude as a result of our investigation that your account has been incorrectly debited, we will respond to your query by arranging for your financial institution to adjust your account accordingly. We will also notify you in writing of the amount by which your account has been adjusted. If we conclude as a result of our investigation that your account has been incorrectly debited we will respond to your query by providing you with reasons and any evidence for this finding in writing.

ACCOUNTS

You should check:

- > with your financial institution whether direct debiting is available from your account as direct debiting is not available on all accounts offered by the financial institution.
- > your account details which you have provided to us are correct by checking them against a recent account statement; and
- > with your financial institution before completing the DDR if you have any queries about how to complete the DDR.

CONFIDENTIALITY

We will keep any information (including your account details) in DDR confidential. We will make reasonable efforts to keep any such information that we have about you secure and to ensure that any of our employees or agents who have access to information about you do not make any unauthorised use, modification, reproduction or disclosing of that information. We will only disclose information that we have about you:

- > to the extent specifically required by law; or
- > for the purpose of this agreement (including disclosing information in connection with any query or claim).

NOTICE

If you wish to notify us in writing about any matter relating to this agreement, you should write to: Hume Islamic Youth Centre, PO Box 2100, Meadow Heights, VIC. 3048. We will notify you by sending you a notice by ordinary post to the address you have given us in the DDR. Any notice will be deemed to have been received on the third banking day after posting.
